

- 11. STORAGE**
- : Store the material in a Clean Dry place, Preferably at 20°C - 35°C.
 - : Keep away from Direct Heat & sunlight.
 - : Keep the container tightly closed.
 - : If the product becomes frozen in HM-HDPE carboys, then keep the same in hot room of 50°C (avoid direct heating)
- 12. HANDLING**
- : Avoid ingestion ;
 - : Avoid contact with Eyes & Prolonged contact with skin & clothing ;
 - : In case of contact with eyes & skin, seek adequate & timely medical attention.
 - : Once the carboy is opened, ensure airtight closure after usage & use the product within a week.
